FUND OBJECTIVE

The Fund's primary investment objective is to seek current income. The Fund's secondary investment objective is to seek exposure to the performance of one or more exchange-traded funds whose shares trade on a U.S.-regulated securities exchange and that seek daily leverage investment results of 3 times (300%) the daily percentage of the common stock of Nasdaq-100 Index (NASDAQ: QQQ) (the "Underlying Stock") subject to a limit on potential investment gains.

²A put option is a contract that gives the buyer the right, but not the obligation, to sell an underlying asset at a specified price (the strike price) by or on a specific date (the expiration date).

³Is the annual rate an investor would receive if the most recent distribution remained the same going forward. The rate represents a single distribution from the fund and does not represent total return to the fund. The distribution rate is calculated by annualizing the most recent distribution and dividing it by the most recent NAV (as of July 03, 2025).

⁴The 30-Day Yield represents net investment income earned by the Fund over a 30-Day period expressed as an annual percentage rate based on the Fund's share price at the end of the 30-Day period (as of June 30, 2025)
