
What is the product?

Term of the PRIIP

What are the risks and what could I get in return?

We have classified this product as 7 out of 7, which is the highest risk class.

This rates the potential losses from future performance at a very high level, and poor market conditions are very likely to impact the performance. What happens if GraniteShares Financial plc is unable to pay out?

How long should I hold the product and can I take my money out early?

Recommended holding period: One (1) day

Holding this product for more than one day is likely to result in a return which is different than -3times the return of the Underlying Stock over that holding period.
