INVESTMENT OBJECTIVE

The Fund seeks daily investment results, before fees and expenses, of 2 times (200%) the daily percentage change of the common stock of Rivian Automotive Inc. (NASDAQ: RIVN). **There is no guarantee the Fund will meet its stated objective. The fund should not be expected to provide 2 times the cumulative return of RIVN for periods greater than a day.**

UNDERLYING STOCK

Rivian Automotive, Inc., based in Irvine, California, designs and manufactures electric vehicles like the R1T pickup, R1S SUV, and EDV with Amazon. It offers fleet management via FleetOS and services like repair, financing, and charging through the Rivian Adventure Network, focusing on sustainable, adventure-ready EVs.

The Fund seeks daily leveraged investment results and are intended to be used as short-term trading vehicles. The Fund is very different from most mutual funds and exchange-traded funds. Fund does not invest in the underlying stock.

The Fund seeks daily leveraged investment results and are intended to be used as short-term trading vehicles. This Fund attempts to provide daily investment results that correspond to the respective long leveraged multiple of the performance of its underlying stock (a Leverage Long Fund).

Investors should note that such Leverage Long Fund pursues daily leveraged investment objectives, which means that the Fund is riskier than alternatives that do not use leverage because the Fund magnifies the performance of its underlying stock. The volatility of the underlying security may affect a Funds' return as much as, or more than, the return of the underlying security.

Because of daily rebalancing and the compounding of each day's return over time, the return of the Fund for periods longer than a single day will be the result of each day's returns compounded over the period, which will very likely differ from 200% of the return of the Underlying Stock over the same period. The Fund will lose money if the Underlying Stock's performance is flat over time, and as a result of daily rebalancing, the Underlying Stock volatility and the effects of compounding, it is even possible that the Fund will lose money over time while the Underlying Stock's performance increases over a period longer than a single day.

Shares are bought and sold at market price (not NAV) and are not individually redeemed from the ETF. There can be no guarantee that an active trading market for ETF shares will develop or be maintained, or that their listing will continue or remain unchanged.
