
What is the product?

Objectives	GraniteShares 3x Long Barclays Daily ETP is designed to enable investors to gain Solactive Daily Leveraged 3x Long Barclays PLC Index time exposure to a total return investment in 3 (the "Underlying Stock") Barclays PLC undefined.
